Administrative/Biographical history:

The Army Inquiry Committee was appointed by President Cosgrave on 3 April 1924 to 'enquire into the facts and matters which have caused or led up to indiscipline and mutinous or insubordinate conduct lately manifested in the Army'ⁱ. The appointment of the Committee followed a tumultuous period for the Army. With the return of peaceful conditions following the close of the Civil War, fast pace demobilisation was necessary to reduce the strength of the wartime Army, and reduce expenditure. An earlier reorganisation created insecurity within Army circles and caused a number of influential Officers to pursue an agenda to revive allegiances to the pre-Treaty Irish Republican Army (I.R.A.), and to the ideals of the deceased General Michael Collins. The manifestation of these efforts was the Irish Republican Army Organisation and the formation of affiliated command clubs Army wide.

As a result of demobilisation pursued by General Headquarters with vigour in autumn 1923, a considerable number of Officers with pre-Truce experience were demobilised with little or no raison d'etre. There was a view held by I.R.A. Organisation members that preferential treatment was given to Officers with links to the Irish Republican Brotherhood (I.R.B.) and Officers with foreign Army experience (including in the

British Army), with many "undesirable persons"ⁱⁱ retaining their ranks and receiving elevated army appointments following the reorganisation.

Prior to the acceleration of demobilisation, a number of clandestine meetings took place between Army higher command, Politicians and a deputation of disgruntled National Army Officers, led by Major General Liam Tobin and Major General Charles Dalton, the architects of the I.R.A. Organisationⁱⁱⁱ. The deputation, led by Tobin, met with President Cosgrave and General Mulcahy (who was at that time Commander in Chief and Minister for Defence) on 25 June 1923^{iv}, and a document setting out the objects of the I.R.A. Organisation was read by Tobin. The document directly questioned the commitment of General Headquarters staff to the Republican ideal and inferred that the Army hierarchy operated under a secret I.R.B. influence. Tobin and the deputation pressed for the establishment of an inquiry to investigate their claims.

"The actions of the present G.H.Q. staff since the C.-in Cs death, their open and secret hostility towards us, his Officers, has convinced us that they have not the same outlook as he had [....]"

The meeting ended abruptly according to sources and without resolution. Further meetings were held "off the record" during the summer period between interchangeable representatives of General Headquarters, the Executive council and the I.R.A. Organisation deputation. At the same time, the I.R.A. Organisation continued to organise command clubs and circulate literature about their organisation outside the Officer class and amongst the N.C.Os and men. The reach of the I.R.A. Organisation increased and a representative meeting of Officers from all commands was held on 22 June 1923. A deputation of six Officers were nominated to engineer a further meeting with General Mulcahy "to impress upon him what they thought was a very serious situation"^v. The deputation was successful in meeting Mulcahy the following month and they managed to secure an assurance that channels of communication would be kept open for further discussion^{vi}. However, in spite of promises, communications stalled in the following period, and Tobin and Dalton held the view that further discussions "would serve no useful purpose"^{vii} and the crisis deepened.

The autumn months of 1923 saw an acceleration of demobilisation especially in consideration of 'surplus', unplaced Officers. The I.R.A. Organisation leaders faced a situation whereby their numbers within the Army were dwindling, confirming, in their mind, a much harboured suspicion that an anti-national sentiment was directing the influence of decision makers tasked with downsizing the Army. Attempts by Government departments (notably the Department of Industry and Commerce) to enhance employment prospects for demobilised personnel outside the Army, and to offer financial compensation did not dial down the situation. In November 1923, seven Officers, all members of the I.R.A. Organisation (Curragh camp) refused to accept demobilisation notices which had come down the line following the circulation of Defence Order No. 28 (15 September 1923). Their defiance inspired other side-lined Officers and a total of sixty Officers refused to accept demobilisation notices and surrender kit and equipment. The sixty Officers were forcibly removed from the Curragh and were refused demobilisation pay and grants. The noticeable resistance of the Officers was taken on board by the Government, and in spite of General Mulcahy's protestations, a redress board known as the Cabinet Committee on demobilisation was established to accept and investigate claims for reinstatement made by Officers with pre-Truce service^{viii}.

The Cabinet Committee operated under particular limitations, notably the reticence of Mulcahy to engage with it, and the resignation of Joseph McGrath, Minister for Industry and Commerce from the Committee midway through the process. McGrath's decision was prompted by what he saw was the aim of other Committee members to merely endorse the initial decisions of the Army Council. It should be noted that no special recommendations were made in any case, and applicants were encouraged to accept their demobilisation papers in a timely fashion so they could apply for a special grant/allowance before the set closing date. The fact that the Cabinet Committee was set up and manned by politicians and senior civil servants, rather than Army personnel was seen by many as a criticism of the ability of the Army Council to manage Army affairs.

The Army crisis culminated in the presentation of an ultimatum written by Major General Liam Tobin and Major General Charles Dalton to President Cosgrave. President Cosgrave read the letter into the Dáil record, sharing its contents, and the intent of its authors with a public audience.

The ultimatum placed two key demands on the Government of the day;

"[...] we demand a conference with representatives of your Government to discuss our interpretation of the Treaty on the following conditions:-

- a. The removal of the Army Council
- b. The immediate suspension of Army demobilisation and reorganisation [...]"

Tobin and Dalton, feeling that an "anti-national spirit"^{ix} was leading peacetime Army reorganisation, demanded the resignation of the Army Council and called for the cessation of Army reorganisation. There were immediate repercussions in both Government circles and within the Army, including key resignations such as Joseph McGrath, Minister for Industry and Commerce who resigned in protest against orders

"When the document was received by the President and placed by him before his colleagues in the Executive Council, there was no alternative to regarding this matter as constituting mutiny, and something more than mutiny – mutiny plus treason" Mr. O'Higgins, Dáil Éireann debate, Wednesday 12 March 1924

to arrest Tobin and Dalton. The absconding of military personnel and the taking of military equipment and armament from Army stores by supporters of Tobin and Dalton was also widely reported^x. The term 'mutiny' featured in resulting Dáil discussions and press reports.

The settling of terms with the 'mutineers' was entrusted to Kevin O'Higgins, Vice President of the Executive Council, who was acting on behalf of President Cosgrave. Joe McGrath T.D. acted as a broker between the Executive council and the 'mutineers' and terms were settled on 12 March 1924. Government concessions included a political commitment to set up of a Committee of inquiry into Army administration and on the military side, an assurance was given to cease raids and to manage an amnesty which allowed for the return of stolen equipment to Army stores. In return, Tobin and Dalton rescinded the original ultimatum and O'Higgins embarked on a damage limitation exercise to explain away the crisis in the Dáil chamber. However, a number of deputies were not satisfied with O'Higgins' interpretation of the crisis and felt the matter needed to be probed further considering the serious charges made against the Army of the day and individual members of the Army Council.

Suspicion that the crisis was far from over was fuelled by intelligence reports on the activities of Dalton, Tobin and supporters which suggested the group were planning a coup d'état. On the evening of 18 March, following an intelligence tip off, a meeting of leading 'mutineers' was disrupted by troops acting under the orders of General Mulcahy (Minister for Defence) and Adjutant General, Gearóid O'Sullivan. Arrests were made following a protracted stand-off and authorised by fresh orders issued by Adjutant General, Gearóid O'Sullivan^{xi}. The action was seen as a "dastardly act as treachery"xii by chief members of the I.R.A. organisation. The Government also condemned the raid on the public house and the arrests, and demanded the resignations of the Army Council, and the dismissal of Richard Mulcahy as Minister for Defence. High level resignations were forced across General Headquarters, including the resignation of Gearóid O'Sullivan (Adjutant General) and Sean O'Murthuile (Quartermaster General). The Chief of Staff, Sean MacMahon held firm under pressure and queried the demand placed on him to resign. He was subsequently dismissed, only to be reinstated months later to a different post when the crisis had died down. Vacancies at higher Army level were filled by Government appointee, General Eoin O 'Duffy (acting in a newly created post, General Officer Commanding the Forces) who swiftly filled the posts of Adjutant General, Chief of Staff and Quartermaster General with his nominees.

Fulfilling his promise made on 12 March 1924, President Cosgrave worked towards the setting up of an inquiry into Army administration and indiscipline i.e. the genesis of the Army crisis. Cosgrave wrote to P. McGilligan, T.D. and Minister for Industry and Commerce on 5 April 1924^{xiii} following his announcement in the Dáil (3 April 1924) to establish the Army Inquiry Committee. Cosgrave suggested that the Committee should commence its deliberations at the earliest possible date and proposed a time, date and location, and set out the terms of reference. In the same letter, Cosgrave introduced his assistant secretary to McGilligan and offered his services to the Committee.

The Army Inquiry Committee met, for the first time on 7 April 1924 in the Council Chamber, Government Buildings, and concluded its work on 7 June 1924 with the submission of its final report to President Cosgrave. During the two month period, the Committee met forty one times (41) and examined twenty seven (27) witnesses.

Paperwork in the collection shows that initial work was delayed owing to the fact that Committee members had to complete groundwork in identifying persons likely to be material to the inquiry, assembling documentation and making contact. President Cosgrave assisted in making contact with particular witnesses including the Judge Advocate General (Cahir Davitt) and the Director of Intelligence (Michael J. Costello)^{xiv}. Committee members also discussed a request made by independent Counsel representing General Mulcahy and other Generals in which Counsel asked for leave to cross examine particular witnesses (mainly Kevin O'Higgins). In advance of the first hearing and to mitigate delays and ambiguity, Committee members also discussed the legal weight of hearsay evidence in expectation that such evidence could come before the Committee. Initial contact with witnesses mainly came from James Creed Meredith, K.C, Chairman of the Army Inquiry Committee and potential witnesses were invited to supply relevant information by way of written statement in advance of their appearance before the Committee itself^{xv}.

A great deal of secretarial work was carried out before, during and after each meeting. All witnesses that appeared before the Committee were presented with a copy of evidence soon after their appearance and copies were produced for each Committee member to allow for afterhours deliberation. Witnesses included senior officials from the Department of Defence, Government Ministers, Army Directors, and members of the late Army Council (General Mulcahy, Lieutenant General Sean MacMahon, Lieutenant General Gearóid O'Sullivan and Lieutenant General Sean O'Muirthile), who were represented by legal representatives. The Committee explored the circumstances which likely influenced the direction of the Army Council in dealing with demobilisation and probed the effectiveness and competency of Army administration during and after the Civil War. The Committee published the 'Report of the Army Enquiry Committee, 7 June 1924' and presented the report to the Dáil. The Report was signed by the five members of the Committee, and in the case of the Chairman, James Creed Meredith, subject to a reservation (contained in an extended report which is held in the collection).

Scope and Content:

- AMTY- 01 Papers of the Cabinet Committee established to investigate claims for reinstatement by demobilised Officers (December 1923 March 1924). Fifty nine (59) files mostly containing application forms completed by Officers that were demobilised as a consequence of Army reorganisation and demobilisation measures. Files also contain related correspondence between the Secretary, Minister of Defence, the Secretary, Cabinet Committee and members of the Cabinet Committee.
- AMTY 02 Army Inquiry Committee –establishment and preliminaries. Three (3) files containing paperwork on the setting up of the Committee
- AMTY 03 Army Inquiry Committee hearings and statements. Seventy two (72) files containing record of evidence produced in line with the appearance of witnesses before the Army Inquiry Committee. Includes supplementary statements and questionnaires supplied by witnesses and related correspondence between Committee members and witnesses.
- AMTY 04 Army Inquiry Committee Administration and report. Six (6) files containing draft reports and final report. With bound volume containing minutes of Committee meetings signed by Committee Chairman.

O'Connell acknowledged difficulties experienced by him in terms of his own staff's expertise and the authority they held, adding "They [the Generals in command] sent me all the duds". The Committee's questioning of Commandant Costello focused on Costello's awareness of growing dissatisfaction amongst army personnel. The Committee asked Costello to produce a report and if he would be amiable to appearing at a later date to discuss it. Costello responded by expressing concern that any assistance he gave to the Committee could prejudice his current appointment (as Director of Intelligence) yet promised to produce a preliminary report by a set deadline. Report also includes evidence supplied by Captain Murray as to his position as Secretary to a Cabinet Committee which was constituted to examine 60 cases of particular demobilised/dismissed Officers.

Each copy is held in a separate file cover marked for 'for Chairman' Gerald Fitzgibbon K.C.', 'For Deputy McGilligan', and 'Spare' files contains a corrected copy of report (corrections to grammar and spelling evident). Discussions between O'Connor and the Committee members were brief and related to memoranda prepared by O'Connor for the Committee. Permission was given by O'Higgins to allow legal representatives (of Mulcahy) to question him in connection with a statement made by O'Higgins' comments which asserted that "Some members of the Executive Council came gradually to the view that the Army was breaking up into factions societies or combinations" and his view that many officers of the Army seemed to have no defined duties, responsibilities and very little control. O'Higgins referrenced observations made by the Dublin Metropolitan Police (not named) and a view held that some officers were "either actual or potential criminals". O'Higgins referred to monthly confidential reports prepared by the Civic Guard about conditions in each county, and provided extracts from reports which pointed to lawlessness, the presence of armed gangs and agrarian outrages in Leitrim, Cork (West Riding) and Cork (East Riding) during the period September 1923 to January 1924. Maguire focused closely on a statement made by O'Higgins admits he was a member of the LR.B in pre-treaty days), a meeting he attended in June 1923 at which the President (W.T. Cosgrave), Dr. MacNeill, the Minister for Defence (Mulcahy), Sean McMahon and Sean O'Murthuile were also present and the LR.B was discussed. Original report/statement prepared by Colonel Costello, Director of Intelligence **Scope and Content:** addressed to the Chairman, Army Inquiry Committee, 22 April 1924, with appendices. With two (2) typed copies held in a separate file cover marked for 'for Chairman' and 'Gerald Fitzgibbon K.C.'. The report deals with the following areas; facts and circumstances which, in Costello's view, led to the mutiny of a section of the Army. Costello referred to difficulties experienced in the reorganisation of the Army following the I.R.A. split (period March to August 1922) which caused staff vacancies, frequent desertions and fuelled suspicions held by senior officers. Costello added "senior officers naturally gathered around them those men whom they knew intimately and whom they could trust [...]". Costello also spoke of issues arising over the regularisation of the army post January 1923 and redundant posts. Costello confirmed that many officers "not gazetted on account of incompetence were sent to the Officer Training Corps, Curragh" and spoke of the vulnerability of such a position. Costello also spoke of men, he felt had personal attachments to leaders and his belief that the situation of such loyalties created factions and led to the formation of groups "inclined to oppose the authority of the army chiefs". O'Connell also spoke of army reorganisation post January 1923 which led to the commissioning of a number of ex-British army personnel, proposing that such an occurrence led to the resignations of some officers (examples given in appendix 4) and caused discontent amongst the ranks. Costello also cited "outside influences" (freemasonry, communism and politics) as factors which caused problems in the army. Costello included extracts from a report submitted by the Director of Intelligence to the Chief of General Staff (7 February 1924, 1 March 1924) on the subject of the Old I.R.A. Men's organisation and the leaders of particular groups in that organisation- the report highlighted the existence of Group 1 made up of Joe McGrath, Bill [Liam] Tobin, Frank Thornton and Charlie Dalton. Appendices include; copy letter written by Humphrey Murphy, Kerry Irregular to Paul Fitzgerald (26 July 1922): copy letter written by Commandant Ned O'Leary (former Adjutant of 3 Southern Command) who resigned due to the Mutiny: copy 'special' report from Commandant Egan dated 14 August 1923 (submitted to Major General Hogan, then Director of Intelligence) on his visit to Athlone to set up a military intelligence section with commentary on ex-British personnel and influence in the Athlone command citing examples: copy letter (dated 15 November 1923) from an officer in the Officer Training Corps to his friend Michael (an Irregular) about his involvement in the I.R.B in the Curragh camp and their aims: copy report dated 2 February 1924 from ex Lieutenant Patrick Shields to the Dublin Command Intelligence Officer about an encounter he had with another demobilised officer called Monaghan: copy report written by Costello to Major General Hogan (then Director of Intelligence) dated 7 June 1923 titled 'Report on situation from Military Intelligence Section' (6pp.): copy letters captured on 26 March 1924 from Frank Kelly, Dalkey which commented on demobilised officers and Joe McGrath and containing comment "he was plotting to become President": extracts from publications which spoke of a 'dissenting force': copy letter dated 12 March 1924 attributed to Colonel P. Mulcahy's statement includes an opening statement "I cannot but at first express my very deep sense of National humiliation at the circumstances in which this enquiry has come about [...]". Mulcahy refers to Dáil statements which related specifically to the army and its responsibility to the Dáil Eireann Ministry at various points in 1922. He recalled a meeting of the General Officers Commanding in Portobello on 5 November 1922 which was attended by President Cosgrave and where one of the General Officers Commanding (not named) stated "What my officers and men want to know is do you mean to get a Republic" - further to that Mulcahy includes copy of a private letter he received from an undisclosed General Officer Commanding (15 May 1923) in which the Officer commented on a meeting held in connection with army reorganisation and how some of the officers who were in attendance were critical of members of the Government. Mulcahy's statement also includes a list of officers who were also T.D.'s and others that resigned from the army in order to become Dáil representatives. Part of Mulcahy's statement labelled 'Facts about the material roots of the Army', includes data showing the strength of the Army as on 23 November 1921 (based on figures contained in Director of Organisation reports), the handover dates of British War Department properties (barracks, camps, rifle ranges, forts, stations/works, depots, houses, hospitals, offices and gaols) to the Provisional Government presented in alphabetical order (page 8 and 9), details of a memo addressed by Mulcahy to Michael Collins dated 1 July 1922 on a recruitment call for volunteers and concentration points for recruitment (Mulcahy also confirms that authorisation was given by the Executive Council on 21 July 1922 to recruit an army force of 15,000 regulars and 20,000 men for special service), details of a memo to Commander in Chief (Collins) dated 4 August 1922 giving strength of army in each division/command and reporting on the military situation in Waterford, Cork, Kerry, Limerick area and the western area. Mulcahy also included an inventory of pre-Treaty supplies (rifles, revolvers and machine guns) and post-Treaty supplies (akin to pre-Treaty list but with addition of 18 pounders and armoured cars) held by each command. Paperwork on file also includes; statement of prisoners in custody (as on 31 July 1922) and a casualty list. Part of Mulcahy's statement labelled 'Facts about the responsibility for army control from January 1922' accounts for his own position (Minister of Defence from 10 January 1922 and Commander in Chief from 24 August 1922), the work of the Defence Council and the situation which led to the creation of an Army council (28 September 1922). Mulcahy confirmed that the Army council was made up of the Commander in Chief, Chief of Staff, Adjutant General and Directors of Organisation and Intelligence and from January 1923, the Quartermaster General was added and other members removed. Mulcahy also discussed the establishment of the Council of Defence on 17 April 1923 which consisted of the President, the Minister of Home Affairs, the Minister of Industry and Commerce and the Minister of Defence. Mulcahy provided details on its powers and remit. Appendices to the statement include; copy correspondence dated 21 July 1922 between Eamon Price, for Director of Organisation (O'Hegarty) to Commander in Chief referring to attached list of divisions and brigades with names of Officers which fell within the Western Command. Other parts of the statement include, 'facts about the I.R.B.', 'facts about the Tobin group' which includes notes on a meeting held between President Cosgrave, Mulcahy, Liam Tobin, Charlie Dalton, Frank Thornton and C. O'Malley on 25 June 1923 and further meetings held in July - this portion also includes related copy correspondence between Mulcahy and senior Officers including Tom Cullen, J.J. Slattery and C. O'Malley. Other areas in the statement include 'facts regarding demobilisation' and 'facts with regard to the Cabinet Committee set up to deal with the complaints of certain demobilised officers'.

The report also shows that Colonel Charles Russell and Major Stapleton were recalled on 12 May 1924. In Russell's case, he was questioned about the demobilisation of ex-British officers, and a claim made by Colonel Neligan that Russell and Colonel Dunphy were at the head of an organisation made up of ex-British Officers. Major Stapleton was questioned about Liam Tobin and his relationship with General Michael Collins, the Active Service Unit and the Squad. Stapleton, who admitted he was also a member of the Squad, discussed at length, the treatment of members of the Squad after the Truce and the National Army commissions they received. Hogan confirmed that he held was in a position to share this information as he was a member of the I.R.B. and also held position as Director of Intelligence in 1923. The appearance of ex Captain J Corcoran was also recorded. Corcoran read a statement into the record (drawn up 12 May 1924) in which he provided details of the scheme of demobilisation, complaints handed by him in his role as Adjutant 1 Battalion, Military Customs Brigade and his own grievance.

The Committee posed a number of questions to McMahon including questions on the establishment of the Special Infantry Corps (and the request made by the Minister for Home Affairs for the army's assistance in dealing with agrarian issues) and the question of civil authority/control of the army. McMahon was also questioned about the relationship between the Athlone command and the Claremorris commands ("complaint of intrigues that Athlone was being used as a base for fomenting trouble in the Claremorris command") and events leading up to the passing of the Defence Forces Act 1923 (passed 7 August) including the Kennare incident, the setting up of the Supreme Council of War (27 March 1923) and the Council of Defence (28 August 1923). Mulcahy was also presented with figures showing the strength of the pre-Truce I.R.A. and was invited to comment on them (see section E.1).
